



# CONTINUING THE VISION, SERVING OUR COMMUNITY



A hospital to serve Des Moines' western suburbs has been a vision held by Iowa Health – Des Moines for years.

In fact, the land on which the new, state-of-the-art hospital is being built has been owned by Iowa Health for 20 years. It was purchased in 1988 with funds from the Coskery Family Trust. This trust, set up in 1929, stipulated that when the last surviving family member passed away, the trust would be divided between Iowa Methodist Medical Center and Iowa Lutheran Hospital. Louise Coskery passed away in 1982 and with her death, a series of gifts totaling nearly \$3 million were bestowed to Iowa Methodist.



Twenty years ago, Iowa Health’s leadership had a vision, albeit a whisper of an idea at the time — to provide leading-edge healthcare throughout our community. At the 1990 groundbreaking of Lakeview Medical Park, during the beginning of our commitment to provide healthcare to our western communities, attendees literally walked through a ditch and corn field to get to the site — a far cry from what the community has become today.

“On a cold day, we walked around the site through corn stubble to break ground for Lakeview Medical Park. At that time, 60th Street was not yet paved and there were very few offices, houses or buildings in the area. It is exciting that, years later, Iowa Health – Des Moines continues to live its mission to provide healthcare for our entire community,” said Sid Ramsey, Vice President of Business Development and Marketing for Iowa Health – Des Moines.

In 2007, a new groundbreaking was held on that land — the groundbreaking for the long-held vision of a full-service hospital.

The hospital capital campaign, “Continuing the Vision, Serving our Community,” helps to tell the story of how this huge project came to be and about how this hospital will positively impact our community.

Twenty-five years. Our silver anniversary. This November we will celebrate the 25th Festival of Trees & Lights benefiting Blank Children's Hospital — a long, proud history that continues to help children and families across Iowa.

Our history began with an idea. An idea that the Iowa Health Foundation Board Chair at the time said would never last. She gladly stands corrected today, 25 years later, as the honorary chairperson of Festival, Ann Cownie.

Festival has taken us from the Civic Center, to the Downtown Convention Center, then to the State Capitol. The celebration went east to the Iowa State Fair grounds, then downtown to Capital Square, and finally back to the current location at the Polk County Convention Complex.

Each year dedicated chairpersons of the Festival of Trees & Lights spend a year making this event grow and succeed. These Chairs, committee members and hundreds of volunteers serving during the event have played a priceless role.

Over the past 24 years, the five day long event and Gala celebration has raised nearly \$5 million and has supported many different areas of Blank Children's Hospital, making it an even better place for children to receive healthcare. For the past 12 years the funds raised have impacted two incredible programs.

The Child Life Program at Blank Children's is almost completely funded by money raised at Festival — allowing 12 staff to provide services to help children and families adjust to healthcare experiences and hospitalization. The impact is as clear as the bubbles that Child Life Specialists blow to distract little patients during a healthcare procedure.

Funds raised also benefit our Center for Advocacy and Outreach — allowing for programs such as "All Heads Covered" that teaches bike safety, a fire safety house that teaches children what to do if in the case of a fire in their home, pedestrian safety, car seat safety and various other community health programs.

"We are so grateful for the funding that comes to us through the Festival of Trees and Lights," said Linda Plummer, Manager, Center for Advocacy & Outreach. "We appreciate the generosity of donors, as it allows us to do important community education programs. With the help of many funding partners, we are able to improve the health and well-being of children in central Iowa and throughout the state."

# JOHN STODDARD CANCER CENTER – RENOVATED INPATIENT ONCOLOGY UNIT OFFERS HEALING AND HOPE TO PATIENTS

Most people have a personal tie to cancer — maybe through a child, spouse, parent or grandparent. For many, that is the reason they chose to support the John Stoddard Cancer Center Adult Oncology Inpatient Unit renovation on Powell 3.

When Mary Kay Jones died of cancer, her family wanted to do something to honor her memory. Troy Jones, Mary Kay's son, and his family started a golf outing in memory of not only their mother, but other family members with cancer. They have been holding the golf outing for years and have supported various organizations. However, the family learned of the Powell 3 renovation project, and they became the first to name a room on the renovated unit.

“My family appreciates the opportunity to help those who will be affected through this, and we will continue to forge ahead supporting the cause in some fashion,” said Troy. “We are also very proud that the room we named is a one-of-a-kind, unique design that has an unspeakable special touch — very much like my mother, Mary Kay Jones!”

The Jones' family now has a way to honor their mother's memory — while also making a difficult, often painful experience a little better for patients of John Stoddard Cancer Center. Without help from donors like the Jones', it would not be possible to do the extras that make a project like this a reality.

“We are very proud of the new John Stoddard Adult Oncology Unit and pleased to offer an updated healing environment for patients and their families that will compliment the great care they receive,” said J. Phil Harrop, executive director of the John Stoddard Cancer Center. “The design team for the new unit included not only physicians and staff members, but also former patients and family members. It was very important for us to create a unit that was unique and special to those that would benefit from it the most.”

Many donors have decided to participate in naming opportunities on the new unit because of personal ties to cancer — some of their stories have happy endings and some have painful endings. Regardless of their story, their generosity lives in the form of gifts to the new unit that will allow for state-of-the-art care in a healing environment.



The new unit features all private rooms, a chapel, laundry and kitchen facilities for families of patients and an attached, outside healing garden. All offer a healing environment designed to make the new unit as calm and relaxing as possible.

## 2007 RALLY AGAINST CANCER ANOTHER SUCCESS

The Rally Against Cancer fundraising event has grown in popularity over its seven years of existence. The event has supported various programs and initiatives at the John Stoddard Cancer Center and raised more than \$180,000 in 2007.

Most recently, the Rally Against Cancer has supported the Cancer Care Coordinator program — a truly unique program to Des Moines. The role of the John Stoddard Cancer Care Coordinators is to educate and support cancer patients and their families for certain types of cancers. Services provided include:

- Serving as a patient advocate
- Providing education to the patient and family
- Offering encouragement and support
- Monitoring symptom management
- Following the patient throughout the care process
- Facilitating a multidisciplinary team of cancer physicians, nurses, dieticians, counselors and social workers
- Raising public awareness about cancer

Most important, the coordinator provides hope and encouragement to patients and loved ones so they can have the best quality of life possible while going through treatment. The Cancer Care Coordinators' services are not reimbursed by insurance, are offered free of charge and are entirely supported through funds raised by the Rally Against Cancer.

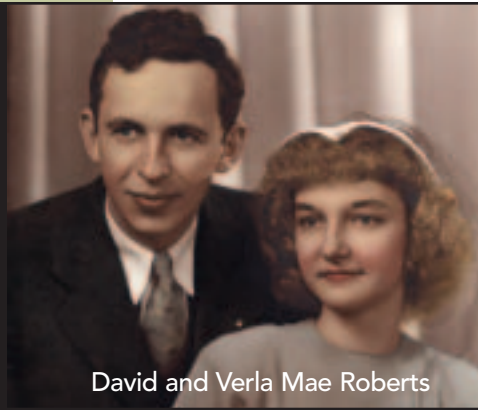

Each year HeartReach and Iowa Health – Des Moines strive to provide heart and vascular screenings to individuals who are unable to access medical care. The HeartReach Mobile Lab is a custom-designed Winnebago, staffed by a cardiac nurse and ultrasound technicians who travel throughout Iowa providing a variety of screenings including; heart and stroke risk assessments, blood pressure tests, blood sugar and cholesterol levels, body weight measurements and EKG testing.

Throughout December 2007, HeartReach provided \$15,000 for in-kind screenings for approximately 130 people. The screenings include: carotid ultrasound, abdominal ultrasound, ankle-brachial index and 12 lead EKG. These free or reduced-cost screenings are made possible in part by donations from the Iowa Health Foundation, The Fraternal Order of Eagles and Iowa Health – Des Moines Cardiovascular and Pulmonary Services.

Many children who come to the units are in need of basic necessities, such as underwear, socks, t-shirts, sweat shirts and other clothes. To help meet this need, the Auxiliary sets aside money for this area for staff to go across the street from Iowa Lutheran to the Not New Shop to buy these much-needed items for patients. In addition, the Auxiliary provides money or periodically drops off fun items such as DVD players and games that can be bought at the Not New Shop — allowing kids to just be kids and play.

"Basically all we have to do is ask and someone comes up with it for us," said Julie Cronk, Manager of Child and Adolescent Behavioral Health. "The staff, and of course our patients, are very grateful for everything the Iowa Lutheran Auxiliary does to support these children."

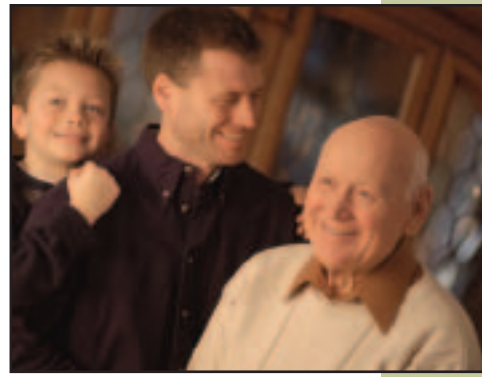

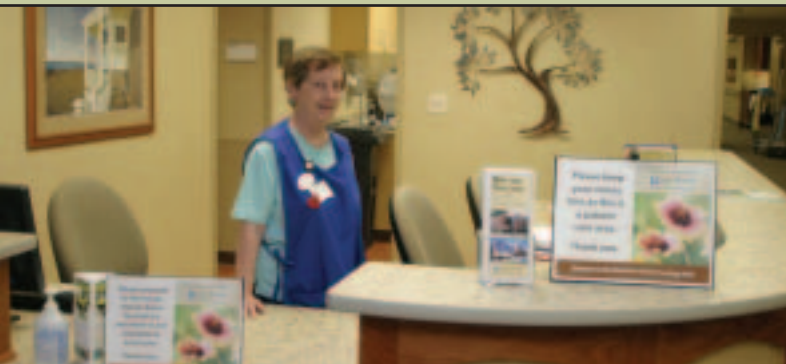
